I hold a PhD. in Political and Social Sciences from the European University Institute, a prestigious postgraduate teaching and research institution established by the European Union in Florence (Italy). My dissertation was entitled "Making Democratic Attitudes Work: The effect of institutions on Europeans aspirations and evaluations of democracy". I pursued my PhD. thanks to a Salvador de Madariaga Fellowship granted by the Spanish Ministry of Education. I have developed my academic career across several research institutions in Europe, such as the European University Institute in Florence (Italy), Maastricht University (Netherlands), the University of Cambridge (United Kingdom), the University of Leicester (United Kingdom), the University of Murcia (Spain) and the Spanish National Research Council in Córdoba (Spain). Prior to my PhD. studies, I worked during a four-year period as a research assistant/associate at the Institute for Advanced Social Studies (IESA-CSIC). After gaining my PhD., I have enjoyed several postdoctoral positions at Maastricht University (Netherlands) and the University of Cambridge (United Kingdom). Furthermore, I have taught courses in politics at Maastricht University (Netherlands) and currently I hold teaching positions at the Center for Higher Education for Business, Innovation and Technology-Rey Juan Carlos University (Spain) and the University of Murcia (Spain). I have participated in several national and international research projects, funded both by European funding programmes (such as the projects COST Action "International Ethnic and Immigrant Minorities Survey Data Network" and "Multicultural Democracy and Immigrants Social Capital in Europe") and by national research institutions (such as the projects "The quality of democracy in Spain: A comparative and empirical perspective", funded by the Spanish Ministry of Science and Innovation, and "Democratic Representation across countries, context and time", funded by the Dutch Research Council). I have attended multitude of national and international conferences and have received extensive training in research methods at the University of Oxford (United Kingdom), University of Ljubljana (Slovenia) and the Berlin Social Science Research Centre (Germany), among others. My work has been published as a monograph by the Centre for Sociological Research and Ariel-Ciencias Sociales. I have contributed chapters in several edited volumes published by Oxford University Press and the Centre for Sociological Research. I am the author of several articles published in top JCR journals such as *Political Studies Review*, Politics, South European Society and Politics, and European Political Science. Together with Dr. Roberto Stefan Foa, I am the guest editor of a special issue on democratic deconsolidation and legitimacy, forthcoming in *Democratization* journal.
